- Classrooms Around the World Pty Ltd is referred to as "The Tour Operator"

PART THREE – TERMS

3.1 The Parent/Guardian hereby grants temporary guardianship to The Temporary Guardian.

3.2 The Guardianship is effective from _____

3.3 The Guardianship concludes _____

3.4 The Parent/Guardian acknowledges that the child will reside with The Temporary Guardian and may travel locally with The Temporary Guardian.

3.5 The Parent/Guardian authorises The Temporary Guardian to act on their behalf in making all decisions on a daily basis as to The Child's activities.

3.6 The Parent/Guardian acknowledges that The Temporary Guardian will be responsible for The Child in all circumstances.

3.7 The Parent/Guardian indemnifies The Tour Operator in relation to any activity the child may be involved in during the time in which the child is in the care of The Temporary Guardian.

3.8 The Parent/Guardian authorises The Temporary Guardian to administer general first aid treatment for minor injuries or illnesses experienced by The Child except where any such first aid treatment is specifically excluded below.

3.9 The Parent/Guardian authorises The Temporary Guardian, in the event that The Parent/Guardian cannot be contacted or if any urgency dictates to act *in loco parentis* for The Child in respect of any circumstances, including any accident or illness, which may necessitate medical treatment, including surgery, and may authorise any such treatment or surgery which The Temporary Guardian in their sole discretion may deem necessary. Medical treatment for The Child may also include dental surgery, x-ray, blood transfusion, anaesthetic and medication provided any such medical treatment is performed by a duly licensed practitioner.

3.10 The Parent/Guardian acknowledges that The Temporary Guardian may provide general support for The Child in the instances of emotional distress, eg. Homesickness.

3.11 The Parent/Guardian accepts full liability for all costs incurred through such medical treatment for The Child.

3.12 The Parent/Guardian is responsible for providing all relevant information to The Temporary Guardian pertaining to The Child's allergies (if any) and special conditions.

3.13 The Parent/Guardian is responsible for providing all relevant information to The Temporary Guardian pertaining to The Child's medication (if any) and how it is to be administered.

3.14 In the case of an emergency The Parent/Guardian notes that they can be contacted during business hours on a number provided to The Temporary Guardian.

3.15 The Parent/Guardian notes The Child is/is not covered by travel insurance for the tour. (Please attach policy details here if applicable).

3.16 The Parent/Guardian declares that they are the Legal Guardian for The Child and have the authority to enter into this Deed. Where two (2) parents share joint parental responsibility consensus as to appointment of Temporary Guardian is required by both parents.

3.17 The Parent/Guardian and The Temporary Guardian agree that the best interests of The Child are the paramount concern.

3.18 The Parent/Guardian and The Temporary Guardian agree that The Temporary Guardian is at least 16 years older than the oldest child in their care (unless otherwise agreed to by all three parties. Those parties being The Parent/Guardian, The Temporary Guardian and The Tour Operator).

3.19 The Temporary Guardian acknowledges that they are committed to caring for the child for 24 hours a day for the duration of the tour. (See 3.2 and 3.3)

3.20 The Parent/Guardian and The Temporary Guardian acknowledge that The Tour Operator may at its sole discretion refuse access to The Child and/or The Temporary Guardian to any part of the tour and that

The Temporary Guardian will be responsible for alternate care of The Child at this time and will be at the expense of The Parent Guardian and The Temporary Guardian.

3.21 The Parent/Guardian acknowledges that they have considered the best interests of The Child in their choice of The Temporary Guardian including consideration of age, character, gender, personal habits and fitness for the appointment.

3.22 The Parent/Guardian acknowledges that the room configurations may result in The Child sharing a room with The Temporary Guardian or being in an adjoining room depending upon the availability of accommodation.

3.23 Unless inconsistent with the context, words signifying the singular shall include the plural and vice versa.
